Part A: Pupil premium strategy plan

Statement of intent

We are an ambitious and inclusive school where our vision is for all pupils to experience *life in all its fullness* now and in the future (see our <u>vision statement.</u>)

We strive for academic excellence for all pupils, regardless of their background, and full participation in all our wide-ranging school activities for all pupils.

Our Pupil Premium Strategy, alongside our wider school improvement plan and equalities plan, is one part of how we seek to redress any inequalities and enable all pupils to achieve highly and experience an inspiring range of opportunities.

We currently have a very small number of pupils eligible for pupil premium funding and these pupils have a wide range of individual and different needs. We track these pupils individually and as a group and we also include in the provision detailed in this strategy a wider group of 'disadvantaged' pupils with individual needs and vulnerabilities.

November 2025 note: In the 25/26 academic year, the number of pupils in our school who are eligible for pupil premium funding has fallen below the statutory reporting threshold, but we believe it is still important to report on and account for the funding and provision for this group.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Supporting attainment and progress – reading, writing and maths We track the progress and attainment of all our pupils individually on a termly basis and we compare the progress and attainment of groups of children according to different characteristics including eligibility for pupil premium. Our analysis of both school-based data for all individuals and classes has shown that some individual pupils who are eligible for pupil premium are not attaining as highly as their peers who are not eligible for pupil premium in either reading, writing or maths.
2	Developing long-lasting positive reading behaviours Our detailed knowledge of what and how children read when they read for pleasure shows us that some of our pupils who are eligible for pupil premium do not have access to the same sources of books or book experiences outside school and do not therefore always develop the same love of reading and positive reading behaviours as their non-disadvantaged peers.
3	Developing vocabulary for oracy and writing Our observations of children's oral language and our knowledge of children's writing shows us that <i>some</i> pupils who are eligible for pupil premium do not use and understand the same level of vocabulary as their peers.
4.	Supporting personal development and well-being Our discussions with pupils and families, including well-being surveys and regular pupil voice sessions, have identified social and emotional issues for some families where children are eligible for pupil premium. We know that for some of these pupils, there are varied barriers to them participating in the same level of extra-curricular and wider

cultural experiences as their peers. We want to support these pupils' well-being and
personal development by ensuring they participate as fully as possible in our wide-
ranging extra-curricular and enrichment activities.

Intended outcomes

This explains the outcomes we are aiming for **by the end of our current strategy plan**, and how we will measure whether they have been achieved.

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2023-2024 academic year (plus some relevant evaluation from previous years).

We continue to track individual pupil progress and attainment each term, adapting our provision and extra support accordingly. For example, our analysis of data (comparison of pupil premium/non-pupil premium group progress and attainment) shows that the gap between attainment in reading of the pupil premium group and other pupils has been closing over the past several years. We believe the closure of the gap over time has been due in part to the positive impact of our pupil premium 'reading for progress and enjoyment' group. In July 2024, all disadvantaged pupils in relevant year groups throughout the school (Y1, Y2, Y4, Y6) at least met expected standards in Reading, with some achieving more highly.

Our pupil premium tracker monitors individual progress and attainment for the small number of pupils eligible for Pupil Premium funding:

- Pupils eligible for pupil premium funding who left Year 6 in 2022 achieved positive end of key stage assessment results (one eligible pupil): Reading: expected; Writing: working towards expected; Maths: expected.
- Pupils eligible for pupil premium funding who left Year 6 in 2023 achieved positive end of key stage assessment results (two eligible pupils): Reading: expected, working towards expected; Writing: expected, working towards expected; Maths: expected, working towards expected.
- Pupils eligible for pupil premium funding who left Year 6 in 2024 achieved positive end of key stage assessment results (two eligible pupils): Reading: both greater depth; Writing: both greater depth; Maths: one expected, one greater depth
- Pupils eligible for pupil premium funding who left Year 6 in 2025 achieved positive end of key stage assessment results (four eligible pupils): Reading: three expected, on greater depth; Writing: all four expected; Maths; one working towards expected, two expected; one greater depth.

In 22/23 and 23/24 some of our eligible pupils participated in series of ten or more additional group sessions with funding provided by both pupil premium and school-led tutoring funds, including 1:1 tutoring sessions for one of our disadvantaged pupils.

In 24/25 some of our eligible pupils took part in after school (and in-school) group and individual booster sessions with their class teachers to support pupil progress.

Positive feedback from pupils and parents also tells us that they value the wide range of opportunities provided at school including the range of after school clubs and our school journey.

In 2022/23 92% of pupils who were eligible for pupil premium funding took part in at least one after school club. All eligible pupils in KS2 had the opportunity to represent the school in a sports event and many also represented the school at an additional enrichment event such as science masterclasses or as part of our Well Being Champions team. All eligible pupils fully participated in all class trips, including the Y6 residential school journey, with funding/part funding for trips and clubs provided through pupil premium funds.

In 2023/24 100% of pupils who were eligible for pupil premium funding took part in at least one after school club. All eligible pupils in KS2 had the opportunity to represent the school in a sports event and many also represented the school at an additional enrichment event such as the inter-school debating competition or as part of our Well Being Champions team. All eligible pupils fully participated in all class trips, including the Y6 residential school journey, with funding/part funding for trips and clubs provided through pupil premium funds.

In 2024/25 100% of pupils who were eligible for pupil premium funding took part in at least one after school club. All eligible pupils in KS2 had the opportunity to represent the school in a sports event and many also represented the school at an additional enrichment event such as as part of school council or our Eco team. All eligible pupils fully participated in all class trips, including the Y6 residential school journey, with funding/part funding for trips and clubs provided through pupil premium funds.
